**PRE-TRIAL CHAMBER I** (“the Chamber”) of the International Criminal Court (“the Court”):

**NOTING** the Warrant of Arrest for Germain Katanga, issued by Pre-Trial Chamber I on 2 July 2007;<sup>1</sup>

**NOTING** the “Information to the Chamber on the execution of the Request for the arrest and surrender of Germain Katanga” filed on behalf of the Registrar by the Director of the Division of Court Services on 22 October 2007;<sup>2</sup>

**NOTING** the “Addendum to the information to the Chamber on the execution of the Request for the arrest and surrender of Germain Katanga” filed on behalf of the Registrar by the Director of the Division of Court Services on 26 October 2007;<sup>3</sup>

**NOTING** the “Order for a Report of Additional Information on the Detention and Surrender of the Detainee Germain Katanga”<sup>4</sup> (“the Order”) issued by the Chamber on 26 October 2007;

**NOTING** the *“Requête aux fins de prorogation de délai pour le dépôt du rapport concernant des renseignements supplémentaires sur la détention et le transfert de Germain Katanga”* filed on 1 November 2007, in which the Registry requested additional time to comply with the Order of the Chamber;<sup>5</sup>

**NOTING** the *“Decision on the Request for an Extension of Time”* of 2 November 2007, in which the Chamber granted the extension of the time limit for the Registrar to file a Report on languages read, spoken or understood by Germain Katanga until 9 November 2007;<sup>6</sup>

**NOTING** the *“Rapport du Greffe relatif aux renseignements supplémentaires concernant les langues parlées, écrites et comprises par Germain Katanga”* filed on 9 November 2007 (*“the Report”*);<sup>7</sup>

**NOTING** articles 67(1)(a) and (f) and 89 of the Rome Statute (*“the Statute”*), rules 101 and 117(1) of the Rules of Procedure and Evidence (*“the Rules”*);

**CONSIDERING** that in the Order, the Chamber decided that *“the Prosecution and Defence may submit observations on the Report of the Registrar within a time limit which will be determined by the Chamber when the Report is filed”*;

**DECIDES** to give until 23 November 2007 at 16h00 for the Prosecution and the Defence to file their observations on the Report.


