PRE-TRIAL CHAMBER I of the International Criminal Court (“the Court”);

NOTING the Decision on the Applications for Participation in the Proceedings of VPRS 1, VPRS 2, VPRS 3, VPRS 4, VPRS 5 and VPRS 6 (“the Decision”) of Pre-Trial Chamber I (“the Chamber”) registered on 18 January 2006;¹

NOTING the Prosecution’s Application for Leave to Appeal Pre-Trial Chamber I’s Decision on the Applications for Participation in the Proceedings of VPRS 1, VPRS 2, VPRS 3, VPRS 4, VPRS 5 and VPRS 6 registered on 23 January 2006;²

NOTING the Observations of the Legal Representative of VPRS 1 to VPRS 6 following the Prosecution’s Application for Leave to Appeal Pre-Trial Chamber I’s Decision on the Applications for Participation in the Proceedings of VPRS 1 to VPRS 6 registered on 27 January 2006;³

NOTING the Prosecution’s Application for leave to reply to the Observations of the Legal Representative of VPRS 1 to VPRS 6 following the Prosecution’s Application for Leave to Appeal Pre-Trial Chamber I’s Decision on the Applications for Participation in the Proceedings of VPRS 1 to VPRS 6 registered on 30 January 2006;⁴

CONSIDERING regulation 24 (5) of the Regulations of the Court;

CONSIDERING that this regulation provides that participants may only reply to a response with the leave of the Chamber;

CONSIDERING that the question of victims participating at the investigation stage has not arisen previously and the fact that for the first time VPRS 1 to VPRS 6 object to an application from the Prosecutor at this stage;
