**PRE-TRIAL CHAMBER I** of the International Criminal Court (the “Chamber” and “Court”, respectively);

**NOTING** the “Prosecution’s Application under Article 58”, filed by the Prosecution on 14 July 2008 in the record of the Darfur situation, whereby a request was made for the issuance of a warrant of arrest against Omar Hassan Al Bashir for genocide, crimes against humanity and war crimes;<sup>1</sup>

**NOTING** the “Decision Convening a Hearing”, issued by the Chamber on 19 September 2008, whereby an *ex parte* hearing with the Prosecution was convened for Wednesday 1 October 2008 at 11.00 hours;<sup>2</sup>

**NOTING** articles 19 and 58 of the Rome Statute;

**CONSIDERING** the need to reschedule the hearing in order to discuss all issues detailed in the agenda included as the *confidential and ex parte* Annex attached to the present decision;

**FOR THESE REASONS**


